- C. Herbert Bolger made a motion to approve entering into negotiations with Delta Airport Consultants to conclude a five-year contract for service to BCAA and AOO. Mike Ritchey seconded the motion. A vote was taken. All board members present voted Aye. Motion passed.
- D. Drew Swope made a motion to approve payment of invoices for Airport Operations from the General Fund in the amount of \$30,529.89, \$12,109.52 of which was paid prior to the meeting. Mike Ritchey seconded the motion. A vote was taken. All board members present voted Aye. Motion passed.
