Manager's Report June 14, 2016

General

- 1. Sun Air's overall completion rate was 98.3% for May, with a controllable completion rate of 100%. Passenger loads ticked up from April and from May of 2015. The reports of completed flights, enplanements, and total passengers are included with this report.
- 2. Three carriers have bid on the AOO EAS service; Boutique Air, Corporate Flight Management, and Southern Airways Express. Comments on the proposals are due to DOT by June 20, 2016. I am recommending that we recommend that DOT accept the Southern Airways Express bid with the two-hub option of flights to both PIT and BWI. If the BWI hub is not well received, we have the option to switch back to an all PIT schedule.
- 3. Because we did not dispute the numbers in the DOT's tentative order relating to EAS service at AOO, it is likely that they will be issuing a formal order to discontinue EAS service at AOO. We must allow the order to be issued BEFORE we can file an appeal for a waiver. We fully expect that we will receive a waiver, but we have to allow the process to work out with a formal order to discontinue, before we file our appeal.

Marketing/Promotion

1. Planning is continuing for the Wings of Freedom visit August 19-21. We have learned that this year's visit by the Colling's Foundation will include four aircraft; a B-17 Flying Fortress, a B-24 Liberator, a B-25 Mitchell, and a P-51 Mustang. The Altoona Antique Auto Club and Corvette Club will have displays on Saturday of the event. The Greater Pennsylvania Military Preservation Association will host displays of military vehicles and weaponry on both Saturday and Sunday, as well as sponsor a hangar dance on Friday evening.

Property

- 1. Safe Q, LLC, is scheduled to begin work on the FBO Fuel Farm repairs on July 1.
- 2. Flightway One, LLC, has provided payment-in-full for the purchase of the DeGol Jet A Fuel System at a price of \$80,000. They are on schedule to have the system removed by June 30, as the sales agreement specifies.
- 3. Atty. Pertile has prepared a draft lease agreement for T-Hangar tenants. This agreement is intended to replace the current leases, which are somewhat of a hodge-podge, or in some cases non-existent. We are under an FAA directive to have this new lease approved by July 31, 2016, so action can be taken tonight, or at our July 11, meeting.
- 4. The PSP have requested a lease extension on their hangar. The extension proposes a 9-month extension, through June 30, 2017, with options for two additional 3 month extensions. There is a motion on tonight's agenda for approval of the lease.

Finance

1. Financial reports for the month of May are included. Invoices for June total \$20,353.11.

In honor of our WWII Veterans ~ The Collings Foundation's Wings of Freedom Tour Brings Extremely Rare Bomber and Fighter Aircraft for Local Living History Display as Part of 110-city Nationwide Tour

WHAT: Participating in the Collings Foundation's WINGS OF FREEDOM TOUR, the WWII B-17 Flying Fortress "Nine O Nine," B-24 Liberator "Witchcraft," B-25 Mitchell "Tondelayo" bombers and P-51 Mustang "Betty Jane" fighter, will fly into Altoona-Blair County Airport in Altoona, PA for a visit from August 19 to August 21. The B-25 is best known for being used in the daring Doolittle raid. Visitors are invited to explore the aircraft inside and out - \$12 for adults and \$6 for children under 12 is requested for access to up-close viewing and tours through the inside of the aircraft. Discounted rates for school groups. Visitors may also experience the once-in-a-lifetime opportunity to actually take a 30-minute flight aboard these rare aircraft. Flights on either the B-17 or B-24 are \$450 per person. Get some "stick time" in the world's greatest fighter! P-51 flights are \$2,200 for a half hour and \$3,200 for a full hour. WHERE: The WINGS OF FREEDOM TOUR will be on display at Altoona-Blair County Airport in Altoona - located at the main ramp.

WHEN: The WINGS OF FREEDOM TOUR will arrive at Altoona-Blair County Airport at 2:00 PM on August 19 and will be on display at main ramp at Altoona-Blair County Airport until the aircraft departs August 21 after 5:00 PM. Hours of ground tours and display are: 2:00 PM through 5:00 PM on Friday, August 19; 9:00 AM through 5:00 PM on Saturday, August 20; 9:00 AM through 5:00 PM on Sunday, August 21. The 30-minute flight experiences are normally scheduled before and after the ground tour times above.

WHY: The WINGS OF FREEDOM TOUR travels the nation as a flying tribute to the flight crews who flew them, the ground crews who maintained them, the workers who built them, the soldiers, sailors and airmen they helped protect; and the citizens and families that share the freedom that they helped preserve. The B-17, B-25 & B-24 were the backbone of the American effort during the war from 1942 to 1945 and were famous for their ability to sustain damage and still accomplish the mission. Despite the risks of anti-aircraft fire, attacking enemy fighters, and the harrowing environment of sub-zero temperatures, many B-17s and B-24s safely brought their crews home. The P-51 Mustang was affectionately known as the bombers "Little Friend" – saving countless crews from attacking axis fighters. After the war, many aircraft were scrapped for their raw aluminum to rebuild a nation in postwar prosperity and therefore very few were spared. The rarity of the B-17, B-25, B-24 & P-51 - and their importance to telling the story of WWII is why the Collings Foundation continues to fly and display the aircraft nationwide. At each location we encourage local veterans and their families to visit and share their experiences and stories with the public.
