Manager's Report September 12, 2016

General

1. Southern Airway's overall completion rate was 96.1% for August, with a controllable completion rate of 97%. Passenger loads up from just over 9% from July, and are just slightly below August of 2015. The reports of completed flights, enplanements, and total passengers are included with this report.

2. DOT has awarded Southern Airways a contract for AOO for the next two years, providing four daily round-trip flights to PIT. The award also gives us the option of requesting a second hub city, as long as the total subsidy required does not change. Southern Airways has agreed to provide two flights/day to PIT and two flights/day to BWI, at the same subsidy level. There is a motion on tonight's agenda to formally request this change from DOT.

3. DOT has issued an order terminating EAS service at AOO. We have 30 days to appeal that order. There is a motion on the agenda to file a formal appeal for a waiver of DOT termination order. We will be working with PIT and their consultant, Meade & Hunt to prepare our appeal.

4. The Consultant Selection Committee is recommending entering into negotiations with Delta Airport Consultants to conclude a five-year contract for engineering services for the BCAA and AOO. There is a motion on the agenda to enter into negotiations for a new fiveyear contract with Delta Airport Consultants.

Marketing/Promotion

1. The Wings of Freedom event was a success. We estimate that upwards of 2,000 people toured the planes that were on display.

2. Southern Airways will begin marketing the new BWI service and continuing PIT service as soon as official approval is given from DOT.

Property

1. Safe Q, LLC, is continuing work on the FBO Fuel Farm. The self-serve unit is nearly complete.

2. Flightway One, LLC, has not removed the DeGol Jet A Fuel system yet. They are currently completing the permitting process at the new location. We have given them a September 30, deadline for removal of the system.

3. We are continuing preliminary planning for construction projects. We may be able to access Capital Budget Grant monies to help offset the costs, and use USDA loan money as our local match. USDA has informed us that they funding for the next fiscal year, beginning on October 1, appears to be stable, with \$60 million in loan funds available for Pennsylvania. Also they Community Facilities Program has now been designated as a "critical" government service, so in the event of a continuing resolution their funding stream will remain intact.

Personnel

1. Our new maintenance employee, Del Hoover, continues to do well. He is scheduled for ARFF training at PIT on September 26-30.

Finance

1. Financial reports for the month of September are included. Invoices for September total \$30,529.89 for the General Account and \$1,425.00 for the Local Project Account.
